## SECTION 4: First-aid measures

---

### 4.1 Description of first-aid measures

#### 4.2 Most important symptoms and effects, both acute and delayed

- Exposure to manganese compounds can lead to symptoms affecting the central nervous system, including neurological disorders (manganism) with symptoms resembling Parkinson's disease, and respiratory issues if inhaled over prolonged periods. May cause irritation to skin, eyes, and respiratory tract.

#### 4.3 Indication of any immediate medical attention and special treatment needed

- None specific, treat symptomatically.

## SECTION 5: Fire-fighting measures

---

### 5.1 Extinguishing media

- **Suitable extinguishing media:** Water, foam, alcohol-resistant foam, fire extinguishing powder. Use extinguishing measures that are appropriate to local circumstances and the surrounding environment.
- **Unsuitable extinguishing media:** Water jet.

### 5.2 Special hazards arising from the substance or mixture

- **Hazardous decomposition products:** Section 10 (Stability and Reactivity).
- **Hazardous combustion products:** Metal oxides (manganese). As an oxidizer, it may intensify fire.

### 5.3 Advice for firefighters

- In case of fire and/or explosion, do not breathe fumes. Coordinate firefighting measures to the fire surroundings. Do not allow firefighting water to enter drains or water courses. Collect contaminated firefighting water separately. Fight fire with normal precautions from a reasonable distance.
  - **Special protective equipment for firefighters:** Use suitable breathing apparatus and full protective clothing.

## SECTION 6: Accidental release measures

---

### 6.1 Personal precautions, protective equipment and emergency procedures

- **For non-emergency personnel:** Remove persons to safety. Ventilate affected area. Do not breathe dust. Wear suitable protective equipment (including personal protective equipment referred to under Section 8) to prevent any contamination of skin, eyes, and personal clothing.
- **For emergency responders:** Wear breathing apparatus if exposed to vapors/dust/aerosols/gases.

### 6.2 Environmental precautions

---

### 7.1 Precautions for safe handling

- Avoid contact with skin and eyes. Do not breathe dust. Use local and general ventilation to prevent fire as well as aerosol and dust generation. Dust deposits may accumulate on all deposition surfaces in a technical room. Avoid release to the environment. Do not eat, drink, and smoke in work areas. Wash hands after use. Preventive skin protection (barrier creams/ointments) is recommended. Remove contaminated clothing and protective equipment before entering eating areas. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. Keep away from clothing and other combustible materials.

## 8.2 Exposure controls

## 10.6 Hazardous decomposition products

# SECTION 11: Toxicological information

---

## 11.1 Information on toxicological effects

- **Acute toxicity:** No specific acute toxicity data for the mixture. Manganese compounds can be harmful if swallowed or inhaled. Oral LD50 (rat) > 2000 mg/kg. Inhalation LC50 (rat) > 5.14 mg/L (4h).
  - **Skin corrosion/irritation:** May cause mild skin irritation.
  - **Serious eye damage/eye irritation:** May cause eye irritation.
  - **Respiratory or skin sensitization:** No information available.
  - **Germ cell mutagenicity:** No data available.
  - **Carcinogenicity:** May cause cancer (Category 1A, H350) based on prolonged or repeated exposure to manganese compounds, particularly via inhalation. IARC: Group 3 (Not classifiable as to its carcinogenicity to humans).
  - **Reproductive toxicity:** No data available.
  - **STOT-single exposure:** No data available. May cause central nervous system effects.
  - **STOT-repeated exposure:** Prolonged or repeated inhalation exposure to manganese dusts/fumes can cause manganism, a neurological disorder affecting the central nervous system.
  - **Aspiration hazard:** Not an aspiration hazard.

## 12.1 Toxicity

- **Aquatic toxicity:** Manganese compounds can be toxic to aquatic organisms at high concentrations. Avoid release to waterways. LC50 (fish, 96h) > 100 mg/L. EC50 (daphnia, 48h) > 100 mg/L.

## 12.2 Persistence and degradability

- Manganese dioxide is an inorganic compound and is not readily biodegradable.

### 12.3 Bioaccumulative potential

- Manganese can accumulate in organisms, but the bioaccumulation potential of manganese dioxide itself is generally low.

### 12.4 Mobility in soil

- Low mobility in soil due to its insoluble nature.
